TAX EFFECTIVE GIVING

Gift Aid

- The Gift Aid programme is very beneficial to us as a charity and is also tax efficient for tax payers. A cash donation, small or large, can qualify for tax relief under Gift Aid as long as the donor is a UK tax payer, pays UK income tax and/or capital gains tax at least equal to the tax that we will claim on his/her donation and completes a Gift Aid declaration.
 - For example: if you give the Serpentine Gallery a donation of £10, the Gallery can reclaim an extra £2.50 from the tax authorities.
- If you pay income tax at the higher rate (40%) or the additional rate (50%) you can also benefit.
 - For example: if you become a Future Contemporary and make a donation of £1,000, as a 40% UK tax payer you could be entitled to claim up to £250 relief from the tax authorities. This means that your donation of £1,000 to the Serpentine would cost you only £750. As a 50% tax payer you could be entitled to relief of up to £375 on a donation of £1,000 and so your donation would be a net cost to you of £625.

Charitable Trust or CAF voucher

- Serpentine Gallery Future Contemporaries donations of £1,000 can be made very simply through a personal or corporate charitable trust or by CAF voucher.
